### Regulations:

- 1. Dog enclosure shall be obscured from view of neighboring properties at grade and adjacent streets.
- 2. Dog enclosure must be located in buildable area directly behind and adjacent to principal building.
- 3. Dog enclosure shall not be located closer to a property line than the principal building.
- 4. Dog enclosure may be constructed of any material permitted for a residential fence.
- 5. No dog enclosure shall be constructed contrary to required vision clearance area requirements.
- 6. Enclosures installed at the rear of double-frontage lots shall adhere to front-yard setback requirements.
- 7. Installation shall be completed within 180 days of issuance of permit.


#### After Approval/Processing of this Dog Enclosure Permit Application:

If you do not intend to proceed with this project, please contact our office at 262.653.4263 to avoid paying the entire cost of the permit. Processing fees will be charged. Any/all unpaid permit fees, along with an additional \$100.00 Administrative Fee, will be processed as a special charge against the real estate upon which the service was performed.

I agree to comply with all applicable codes, statutes, and ordinances, and with the conditions of this permit; understand that the issuance of the permit creates no legal liability, express or implied, on the state or municipality; and, certify that all of the permit information herein is accurate. I am responsible for locating the enclosure on the intended property and certify that the enclosure does not encroach onto the public right-of-way or neighboring properties. I am responsible for removal and replacement of enclosures located in easement areas. I agree to maintain required vision clearance triangle areas. I expressly grant the building inspector, or the inspector's authorized agent, permission to enter the premises for which this permit is sought at all reasonable hours and for any proper purpose to inspect the work which is being done.
