**SPECIFICATIONS AND SPECIAL CONDITIONS**

**WORK TO BE PERFORMED.**

1. Remove concrete foundation walls and floor.
2. All material and debris removed shall be wetted down prior to transport to a regulated and certified landfill for disposal.
3. Cap water and sewer laterals.
4. Restore lot to a rough grade using proper erosion control measures. This is to guarantee an acceptable interim condition until a final grade can be obtained in concert with the razings of two (2) other adjacent properties that will occur in the near future.
5. This is to be an expedited process because of the safety concerns with the site. Therefore, an on-site inspection must be coordinated and performed prior to Friday September 15, 2017 by 2:00 P.M, and a quotation must be either be delivered to the Department of Finance, e-mailed to [purchasing@kenosha.org](mailto:purchasing@kenosha.org) or faxed to 262-653-4190 prior to 4:00 P.M., Friday September 15, 2017.
6. Mobilization of equipment, razing of the concrete components, the removal of the wetted-down material and debris, transport and disposal must be completed by Friday September 22, 2017.
7. Extended work hours, if required would be reviewed, approved or rejected by the Community Development and Inspections Department.
