TO ASSIGN NEW WARD POLLING PLACES FOR VOTING PURPOSES


WHEREAS, Section 5.25 (3), Wisconsin Statutes, requires that the City shall establish polling places at least 30 days before the election; and

WHEREAS, there are more than 30 days before the 2024 Spring Primary (if necessary) and the 2024 Spring Election and Presidential Preference Primary.

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of Kenosha, Wisconsin, that the following named locations shown on Attachment A, and the city polling place map shown on Attachment B, be established as ward polling places.

BE IT FURTHER RESOLVED, that the City Clerk/Treasurer is directed to submit a certified copy of this Resolution and attachments to the Kenosha County Clerk and the Wisconsin Legislative Bureau within five (5) days of the adoption of this Resolution.

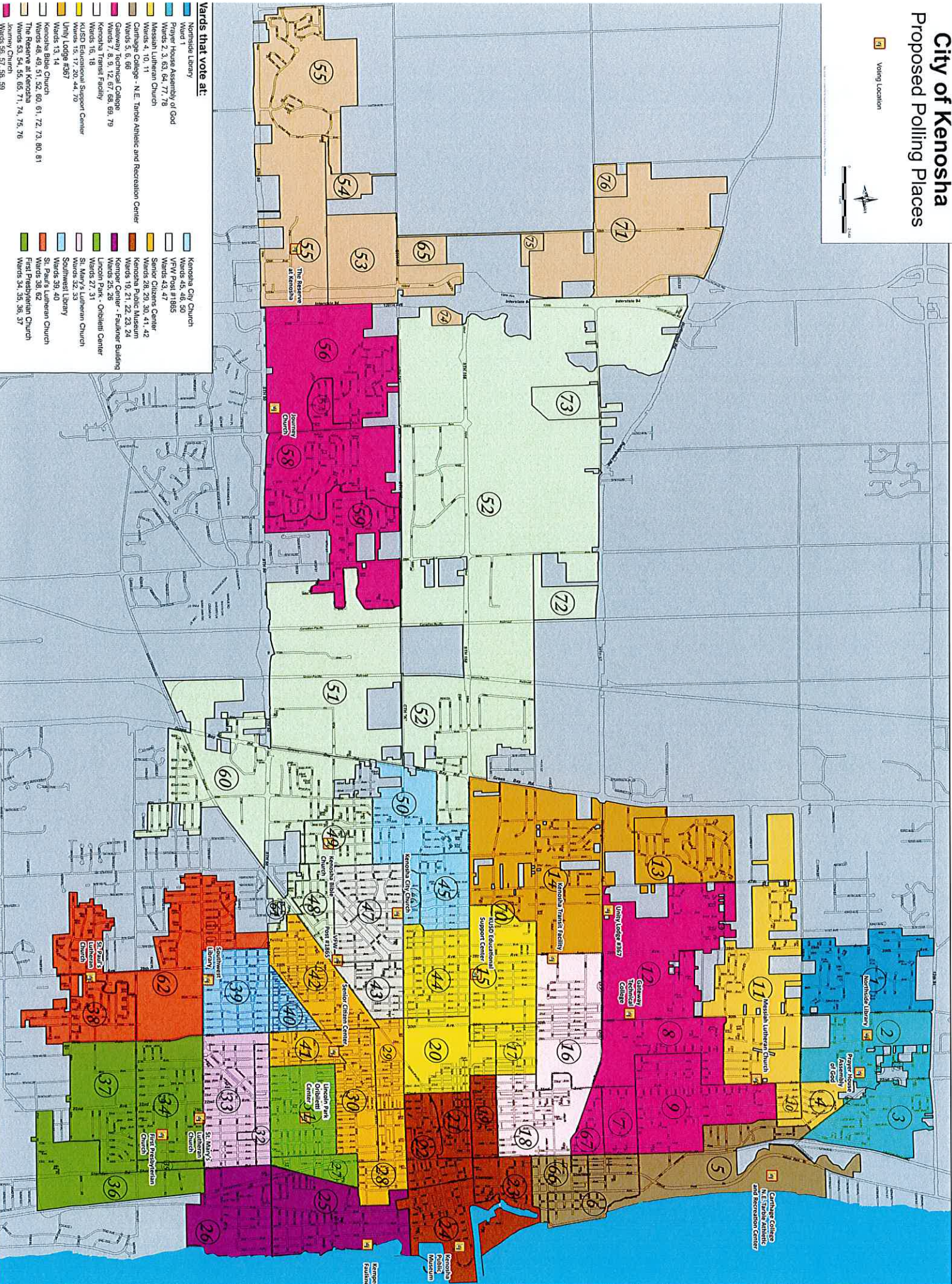
