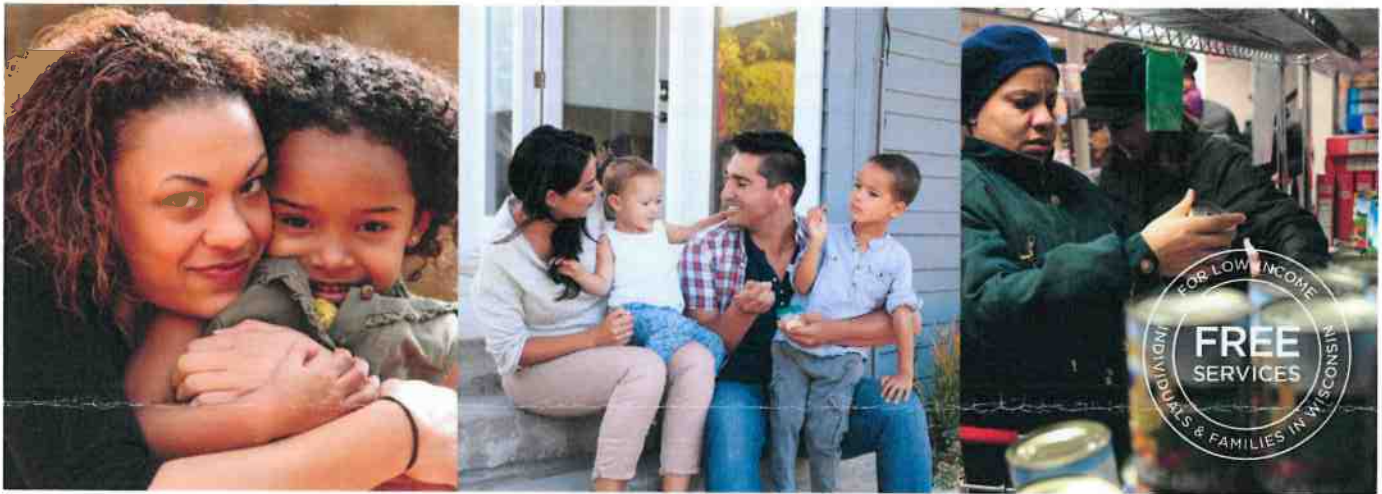




FREE CIVIL LEGAL AID TO LOW INCOME PEOPLE

What are CIVIL LEGAL PROBLEMS?

They vary for individuals and families, but they might include:



BACKGROUND RECORDS
Criminal background records (CIBs) & arrest records



FARMWORKERS RIGHTS
Wages, work **agreements**, & farmworker housing



WELFARE/PUBLIC BENEFITS
Medical Assistance/**BadgerCare**, child care assistance, FoodShare, Social Security, Disability Income (SSI and SSD-I) & Wz



CONSUMER
Debt collection, garnishment, & utilities



HOMEOWNERSHIP
Foreclosures, property taxes, & municipal fines



OTHER
Unemployment compensation, economic development & community revitalization



CRIME VICTIM RIGHTS
Victims of elder abuse, domestic violence, & other crimes



HOUSING
Landlord/tenant, public housing Section 8, & evictions



FAMILY
Divorce, child custody, & placement



LICENSES
Occupational & drivers

Notice of Language Access Rights

It is the policy of Legal Action of Wisconsin, Inc. to provide language access services to populations of persons with limited English proficiency who are eligible to be served or likely to be directly affected by our programs. Legal Action of Wisconsin, Inc. has a grievance procedure to help clients and prospective clients concerning: (a) the quality of legal assistance they have been provided by attorneys employed by Legal Action of Wisconsin; and (b) the denial of legal assistance by attorneys employed by Legal Action of Wisconsin. Persons wishing to complain should contact the Managing Attorney of the office serving the county in which they reside.
