Sealed Quotations shall be submitted on the attached form and returned to the Finance Department. Price Quotations received after the deadline or those transmitted using other electronic means will not be considered.

The City of Kenosha reserves the right to accept or reject any or all quotations and to accept any that are considered to be the most operational and financially advantageous to the City.

The City of Kenosha is exempt from Federal Excise Tax and State Sales Tax, therefore, proposals should be made exclusive of these taxes. A tax exemption registry number or/and a tax exemption certificate will be furnished to the successful vendor.

Quantities herein listed are to be used for evaluation purposes only. A majority of the work will be curb and gutter rehabilitation. The City does not guarantee any definite quantities as they are estimates only. Actual footage will vary and specific locations may be added or deleted, based upon the quotation, in order to meet and stay within budgetary constraints.

A copy of a Certificate of Insurance showing coverages is required with the submittal. The successful contractor will be required to submit a current certificate of insurance with endorsement to the Finance Department, naming the City as an additional insured prior to performing any work. The contractor shall properly protect the work and shall hold the City harmless from all damages to all persons and property occurring in any

way by his or her acts, neglect, or those of his/her agents, employees or workers.

Prices quoted shall be firm for all work completed and approved by the Public Works Street Division representative.

SPECIFICATIONS

This specification is intended to serve as a guideline for proper and efficient execution of Mudjacking/Sawcutting repairs and is based on the past experiences of the City Public Works Department Street Division. Work performed under these specifications shall consist of raising and supporting the concrete pavement to the specified grade tolerances or to tolerances acceptable to a Street Division representative by drilling and injecting grout under the specified sagged areas. The City of Kenosha welcomes proposals from contractors that may result in a more efficient completion of Mudjacking/Sawcutting repairs.

All Mudjacking shall include Sawcutting, if required and/or requested by the City Street Division superintendent or designee. The cost of sawcutting shall be the responsibility of the Contractor and be included in the quotation price.

The contractor shall supply all tools, material, labor, and incidentals necessary to complete the work unless otherwise noted in these specifications.

Upon completion of the Mudjacking, all drill holes shall be sealed flush with the surface of the pavement and filled full depth with a fast setting cement/sand mortar or other material approved by a Street Division Inspector.

Mudjacking shall not be performed when temperatures of the pavement are below thirty-two (32) degrees Fahrenheit, or if the subgrade and/or sub-base material is frozen.

If the pavement binds and does not raise to an acceptable tolerance or is overjacked, no payment will be made for any work performed on that section. Curb and gutter flow lines must be correctly reestablished for payment to be approved on that section.

A Street Division Inspector will carefully check for and mark existing cracks prior to the jacking operation. New cracks radiating diagonally through the grout injection holes will be presumed to have been caused by improper injection techniques. For each two lineal feet of such crack measured, the contractor's payment for the affected section shall be reduced by fifty percent (50%). Since the Contractor will be paid only for

acceptably raised pavement, he shall have the right to refuse Mudjacking pavement which he feels cannot be properly raised.

The Contractor shall remove and dispose of all asphalt which interferes with the mudjack repair. There shall be no additional charges for this service.

The Contractor shall supply all temporary signing, cones and other traffic control devices. All traffic control shall be in accordance with the recommendations in the current edition of the "Manual on Uniform Traffic Control Devices."

Void filling beneath slabs shall be measured from nearest joint to two feet (2') from the farthest hole.

All prices for raising concrete are for voids six inches (6") or less. Curb and gutter shall be measured from joint to joint.

Quantities are estimated. Actual footage will vary and specific locations may be added or deleted in order to meet or to stay within budgetary limits.

It is the intent of the Street Division to perform and complete this work during the 2017 construction year. Upon mutual agreement of both parties, the contract may be extended for one (1) additional construction year with the same terms and conditions that are stated here.

All work performed by the contractor shall be warrantied for a period of one (1) year.
