January 11, 2016
Licensing/Permit Committee

A meeting of the Licensing/Permit Committee was held on January 11, 2016, in Room 204 of the Kenosha Municipal Building.

The meeting was called to order at 6:30 p.m. by Chair Wilson.

At roll call, the following members were present: Alderpersons Juliana, Wicklund, Bogdala and Ruffolo. Assistant City Attorney Matt Knight was present.

Citizen Comments – None.
