Minutes of the Meeting Held January 12, 2015

A meeting of the Licensing/Permit Committee was held on January 12, 2015, in Room 202 of the Kenosha Municipal Building.

The meeting was called to order at 6:30 p.m. by Chair Wilson.

At roll call, the following members were present: Alderpersons Juliana, Wicklund, Ruffolo and Bogdala. Deputy City Attorney Matt Knight was present.

Approval of the minutes of the meeting held December 8, 2014..

It was moved by Alderperson Juliana, seconded by Alderperson Wicklund to approve. Motion carried unanimously.

1. Applications for new Operator's (Bartender) licenses, with a recommendation from the City Attorney to grant, subject to:

It was moved by Alderperson Wicklund to approve a, subject to 75 demerit points. Motion died for lack of a second. It was moved by Alderperson Wicklund, seconded by Alderperson Juliana to approve a, subject to 75 demerit points. Motion carried 3-2, with Alderpersons Bogdala and Ruffolo voting nay. It was moved by Alderperson Juliana, seconded by Alderperson Ruffolo to concur with the recommendation of the City Attorney regarding b. Motion carried 4-1, with Alderperson Wicklund voting nay.

Alderperson Ruffolo spoke in response to Mr. Morgan's questions regarding the demerit point system made during Citizen Comments, stating that Mr. Morgan should contact the City Attorney's office for an explanation of the demerit point system.


