February 8, 2016
Licensing/Permit Committee

A meeting of the Licensing/Permit Committee was held on February 8, 2016, in Room 202 of the Kenosha Municipal Building.

The meeting was called to order at 6:33 p.m. by Chairperson Curt Wilson.

At roll call, the following members were present: Alderpersons Juliana, Wicklund and Bogdala. Alderperson Ruffolo was excused. Deputy City Attorney Matt Knight and special counsel Steve Cain were present.

Citizen Comments – KPD Chief Morrissey spoke on the complaints and misinformation circulating regarding the purpose of the Tavern Unit. He provided 2014-2015 statistics on the amount of inspections performed, the amount of violations, and the amount of citations issued.

Shirley Willie, Richard Willie, Alderperson Bob Johnson, Frank Carmichael and Cidney Bindelli spoke in support of the Brat Stop and the unfairness of the demerit point system.

Approval of the minutes of the regular meeting held January 25, 2016.

It was moved by Alderperson Juliana, seconded by Alderperson Wicklund to approve. Motion carried unanimously.

City appeared by Deputy City Attorney Knight. Licensing/Permit Committee appeared by Special Counsel Steve Cain. Licensee appeared and was represented by Attorney Loren Keating. PO's Martin Howard, Albert Gonzales and Jason Tetrick were sworn in

and testified. David Church, Sean Flahive, Elizabeth Raymer, Elizabeth Ortiz and Jerry Rasmussen were also sworn in and testified. It was moved by Alderperson Wicklund, seconded by Alderperson Bogdala to go into closed session at 11:10 p.m. Motion carried unanimously. It was moved by Alderperson Bogdala, seconded by Alderperson Wicklund to reconvene into open session at 12:21 a.m. Motion carried unanimously. It was moved by Alderperson Wicklund, seconded by Alderperson Juliana that 1) no disciplinary action be taken; 2) demerit points related to the Class "B" Beer/ "Class B" Liquor License be reduced to 95 demerit points; and 3) demerit points related to the Amusement and Device License be reduced to 75 demerit points. Motion carried 3-1, with Alderperson Bogdala voting nay.

ALDERPERSONS' COMMENTS: Alderperson Wicklund spoke regarding compliments paid to the Kenosha Police Department from citizens in attendance at the Public Safety & Welfare meeting. He also apologized to the Tavern Squad for deferring item 4, but felt it was necessary that they appear.

NOW THEREFORE, based on the extensive testimony and evidence received at the hearing, the arguments of counsel for the City, the arguments of the Attorney for the Licensee, the stipulations of the parties, and the discussion by the members of the Licensing/Permit Committee, the Licensing/Permit Committee of the Common Council of the City of Kenosha makes the

following Findings of Fact, Conclusions of Law and Recommendation:

FINDINGS OF FACT

1. Norma Rasmussen, agent of Brat Stop, Inc., d/b/a Brat Stop, hereinafter “Licensee”, at all times mentioned herein, was and is an adult resident of the City of Kenosha, Wisconsin, and as of April 15, 2014, resided at 6042 – 41st Avenue, Kenosha, Wisconsin;

2. Licensee was initially granted a Class “B” Beer/“Class B” Liquor Combination License, hereinafter “License”, by the Common Council for the City of Kenosha, Wisconsin, hereinafter referred to as “Council”, pursuant to Chapter 10 of the Code of General Ordinances of the City of Kenosha, Wisconsin;

3. The Licensee has filed renewal applications for each successive year with its most recent renewal application for renewal of the Class “B” Beer/ “Class B” Liquor Combination License dated April 15, 2015, for the licensing period beginning on July 1, 2015 and concluding on June 30, 2016.

4. Licensee was granted an Amusement and Recreation Enterprise License for the 2015/2016 licensing term by Council on May 4, 2015, pursuant to Chapter 12 of the Code of General Ordinances subject to a nonrenewal revocation hearing.

5. The Licensee had its Class “B” Beer/ “Class B” Liquor Combination License renewed by Council on May 18, 2015, subject to a nonrenewal revocation hearing;

CLASS “B” BEER/“CLASS B” LIQUOR LICENSE

6. That Licensee was assessed twenty-five (25) demerit points based upon citations issued to Licensee and Licensee's employee, Karl Sovich, for Sale of Alcohol to an Underage Person, contrary to Wisconsin Statute §125.07(1)(a), pursuant to Sections 10.063 D.1. and 10.063 D.6., of the Code of General Ordinances, said violation having occurred on November 21, 2013, resulting with a conviction of Licensee's employee in the City of Kenosha Municipal Court on

December 12, 2013;

7. That Licensee was assessed fifty (50) demerit points based upon citations issued to Licensee and Licensee's employee, Elizabeth Raymer, for Sale of Alcohol to an Underage Person, contrary to Wisconsin Statute § 125.07(1)(a), pursuant to Sections 10.063 D.1., 10.063 D.6. and 10.063 D.8., of the Code of General Ordinances, said violation having occurred on February 21, 2014, resulting with a conviction of Licensee's employee in the City of Kenosha Municipal Court on May 19, 2014;

8. That Licensee was assessed fifteen (15) demerit points based upon citations issued to Licensee and Licensee's employee, Elizabeth Raymer, for Permitting an Underage Person to Loiter on License Premises, contrary to Wisconsin Statute §125.07(3)(b), pursuant to Sections 10.063 D.1. and 10.063 D.6., of the Code of General Ordinances, said violation having occurred on February 21, 2014, resulting with a conviction of Licensee's employee in the City of Kenosha Municipal Court on May 19, 2014;

9. That the presumptions given to the conviction and the associated fifteen (15) demerit points alleged in paragraph 8 herein have been factually rebutted by testimony an employee of the Licensee, specifically that the Brat Stop, Inc. was open for normal restaurant business, and should not be considered.

10. That Licensee was assessed twenty (20) demerit points based upon a citation issued to Licensee and Licensee's employee, Elizabeth Ortiz, for Sale of Alcohol to an Intoxicated Person, contrary to Wisconsin Statute §125.07(2), pursuant to Sections 10.063 D.1. and 10.063 D.6., of the Code of General Ordinances, said violation having occurred on June 1, 2014, with a conviction of Licensee's employee in the Municipal Court for the City of Kenosha on August 5, 2014;

AMUSEMENT AND RECREATION ENTERPRISE LICENSE

10. That Licensee was assessed twenty-five (25) demerit points based upon citations issued to Licensee and Licensee's employee, Karl Sovich, for Sale of Alcohol to an Underage Person, contrary to Wisconsin Statute §125.07(1)(a), pursuant to Section 12.01 B.3.a.(1)(a), of the Code of General Ordinances, said violation having occurred on November 21, 2013, resulting with a conviction of Licensee's employee in the City of Kenosha Municipal Court on December 12, 2013;

11. That Licensee was assessed twenty-five (25) demerit points based upon citations issued to Licensee and Licensee's employee, Elizabeth Raymer, for Sale of Alcohol to an Underage Person, contrary to Wisconsin Statute § 125.07(1)(a), pursuant to Section 12.01 B.3.a.(1)(a), of the Code of General Ordinances, said violation having occurred on February 21, 2014, resulting with a conviction of Licensee's employee in the City of Kenosha Municipal Court on May 19, 2014;

12. That Licensee was assessed twenty-five (25) demerit points based upon citations issued to Licensee and Licensee's employee, Elizabeth Raymer, for Permitting an Underage Person to Loiter on License Premises, contrary to Wisconsin Statute §125.07(3)(b), pursuant to Section 12.01 B.3.a.(1)(a), of the Code of General Ordinances, said violation having occurred on February 21, 2014, resulting with a conviction of Licensee's employee in the City of Kenosha Municipal Court on May 19, 2014;

13. That the presumptions given to the conviction and the associated twenty-five (25) demerit points alleged in paragraph 12 herein have been factually rebutted by testimony an employee of the Licensee, specifically that the Brat Stop, Inc. was open for normal restaurant business, and should not be considered.

14. That Licensee was assessed twenty-five (25) demerit points based upon a citation

issued to Licensee and Licensee's employee, Elizabeth Ortiz, for Sale of Alcohol to an Intoxicated Person, contrary to Wisconsin Statute §125.07(2), pursuant to Section 12.01 B.3.a.(1)(a), of the Code of General Ordinances, said violation having occurred on June 1, 2014, with a conviction of Licensee's employee in the Municipal Court for the City of Kenosha on August 5, 2014;

CONCLUSIONS OF LAW

15. As to its Class "B" Beer/"Class B" Liquor Combination License, that Licensee has accumulated ninety-five (95) demerit points within seven hundred thirty (730) consecutive days pursuant to Section 10.063 of the General Code of Ordinances;

16. Pursuant to Section 10.063 D.2.a., of the Code of General Ordinances, the accumulation of one hundred (100) demerit points within seven hundred thirty (730) consecutive days subjects the Licensee to the nonrenewal, revocation or suspension of said License held by Licensee, as determined by Council.

17. As to its Amusement and Recreation Enterprise License, that Licensee has accumulated seventy-five (75) demerit points within seven hundred thirty (730) consecutive days pursuant to Section 12.01 of the General Code of Ordinances;

18. Pursuant to Section 12.01 B.3.a., of the Code of General Ordinances, the accumulation of one hundred (100) demerit points within seven hundred thirty (730) consecutive days subjects the Licensee to nonrenewal, revocation or suspension of its Amusement and Recreation Enterprise License, as determined by Council.

RECOMMENDATION

Based on the allegations of the Complaint, the evidence and testimony received at the hearing, the presumptions rebutted by testimony, the arguments of Counsel for the City of Kenosha, the arguments of Counsel for the Licensee, the discussions by the members of the Licensing/Permit Committee, and the Findings of Fact and Conclusions of Law set forth above,

the Licensing/Permit Committee recommends to the Common Council, by a vote of 3-1, that no action be taken on the Class "B" Beer/"Class B" Liquor License and the Amusement & Recreation License of Brat Stop, Inc. As support for its decision, the Committee finds the demerit points as to the Class "B" Beer/"Class B" Liquor License demerit points total ninety-five (95) and the demerit points as to the Amusement and Recreation Enterprise License total seventy-five (75).
