A meeting of the Licensing/Permit Committee was held on February 29, 2016, in Room 204 of the Kenosha Municipal Building.

The meeting was called to order at 6:30 p.m. by Chairperson Curt Wilson.

At roll call, the following members were present: Alderpersons Juliana, Bogdala and Ruffolo. Alderperson Wicklund was excused but arrived from the Parks Commission meeting for Item 4. Deputy City Attorney Matt Knight and Inspector Edo Maccari were present. Chief Morrissey was present for Item 9.




