The Department of Community Development & Inspections had requested deferral of this item at the May 31, 2016 meeting due to conflicts on the application regarding capacity and questions on the restrooms. The applicant requested that the item be placed on the June 27, 2016 meeting.

Conflicts still exist. The application indicates twenty (20) seats and the plan indicates approximately thirty-two (32) seats. The applicant said they would reduce the number of seats, but no additional information was provided.

The building inspector also met with the applicant at the site to review the current restroom layout. The existing restroom complies for the current business. The addition of tables inside or outside changes the "occupancy/use" under the Section 29 of the IBC, resulting in different restroom requirements.


In order to comply, the owner would need to make changes by either adding a restroom or making modifications to the existing restroom. No changes have been submitted as of this date. Without making changes, the Outdoor Dining would not comply with the Building Code.

The Department of Public Works has a concern regarding accessibility of the bicycle parking rack. However, there are no standards for minimum clear zones around bicycle parking areas. The Site Plan shows four (4') feet between the bicycle parking rack and the nearest proposed bench/table seating area. There is also five (5') feet between the bicycle parking rack and the planting island and six (6') feet between the bicycle parking rack and the building.

Also, Public Works raised a concern regarding the proximity of the existing adjacent Outdoor Dining Area and Elsie Mae's proposed Outdoor Dining Area and how they will create a 90° turn in the pedestrian walkway. Because the proposed Dining Appurtenances will not be as mobile as tables and chairs, alleviating this concern will require a redesign of both the site and the appurtenances.

Since the request will not comply with the Building Code as presented, a recommendation is made to deny the Outdoor Dining application.
