A. Prohibition - It shall be unlawful for any person, acting as an individual, a partner, a corporate officer, or an agent, to execute or file with any City Department, or to authorize any person to do so on their behalf, a license or permit application which is not true, correct and/or complete in all material respects and which was known by said person to be untrue, incorrect and/or incomplete. The term "in all material respects" shall mean with respect to some fact, which, if known to the granting authority, would be a basis or a consideration for license or permit denial.

B. Penalty 1) Any person violating Subsection A. above, shall, upon conviction thereof, be subject to a forfeiture not to exceed Five Hundred (\$500) Dollars, plus the payment of the costs of prosecution, and, in default of the timely payment thereof, shall be committed to the County Jail until such forfeiture has been paid, but not to exceed a period of thirty (30) days. 2) The license or permit granting authority may grant, but withhold the issuance of, any license or permit for a period not to exceed thirty (30) days from the date of granting under circumstances wherein an application is found by the granting authority to have violated Section A. above, and the applicant was provided with an opportunity to appear before the granting authority. The granting authority may also issue a written warning to the applicant which shall be made part of their license/permit record for two consecutive license/permits years. Where such finding and penalty is made and imposed by other than the Common Council, applicant may, within ten days of receipt of oral or written notice of the imposition of any such penalty, whichever is first, if both oral and written notice is provided, file a Notice of Appeal with the City Clerk and have such matter reviewed by the Common Council.

Per §1.225 of the Code of General Ordinances, "The first Twenty-Five Dollars of the application fee for any License/Permit shall be retained by the City in the event of a License/Permit denial or the withdrawal of the application by applicant for administrative and processing costs, and the balance, if any, refunded to the applicant. Where the application fee is less than Twenty-five Dollars, the entire application fee shall be retained by the City for administrative and processing costs."

Dear Ms. Nelson:

As you are aware, Mr. Kaisani has requested that I send you a letter explaining the event that occurred on June 15, 2013 at Pop's Place. As the news articles and testimony at the previous hearing make clear, the incident on the 15th was solely and completely due to the actions of the DJ. Those actions were taken on the DJ's individual initiative. Neither Dr. Kaisani or Mr. Kaisani directed him to take these steps. At no time was the DJ ever authorized by anyone in authority to defy the police in the performance of their duties.

Mr. Kaisani has fired the offending DJ. A new DJ has been hired. In addition, the music that will be played at the club will be old school R&B and mix music. Further, Mr. Kaisani has instituted a dress code, as a result of which prospective patrons will not be allowed in if they are wearing T-shirts, low-hanging pants or anything other than normal attire and Mr. Kaisani will voluntarily close by 2:00 am on Friday and Saturday. Mr. Kaisani has posted a No Loitering sign on the property and has also directed his security guards to personally escort exiting patrons to their vehicles. When Mr. Kaisani leaves the bar at approximately 2:30 am he inspects the premises to make sure that all trash and refuse has been removed both from the parking lot and adjacent residents' yards.


Finally, Mr. Kaisani has voluntarily limited the number of patrons allowed in the club at any one time to no more than 135, well below the allowable legal maximum of 200 patrons.

PLEASE READ: §1.22 LICENSE/PERMIT APPLICATIONS - CODE OF GENERAL ORDINANCES

Prohibition It shall be unlawful for any person, acting as an individual, a partner, a corporate officer, or an agent, to execute or file with any City Department, or to authorize any person to do so on their behalf, a license or permit application which is not true, correct and/or complete in all material respects and which was known by said person to be true, incorrect and/or incomplete will be denied. The term "in all material respects" shall mean with respect to some fact which, if known to the granting authority, would be a basis or a consideration for license or permit denial.

Penalty

Any person violating Subsection A. above, shall, upon conviction thereof, be subject to a forfeiture not to exceed Five hundred (\$500) Dollars, plus the payment of the costs of prosecution, and, in default of the timely payment thereof, shall be committed to the County Jail until such forfeiture has been paid, but not to exceed a period of thirty (30) days.

The license or permit granting authority may grant, but withhold the issuance of, any license or permit for a period not to exceed thirty (30) days from the date of granting under circumstances wherein an application is found by the granting authority to have violated Section A. above, and the applicant was provided with an opportunity to appear before the granting authority. The granting authority may also issue a written warning to the applicant which shall be made part of their license/permit record for two (2) consecutive license/permit years.

Where such finding and penalty is made and imposed by other than the Common Council, applicant may, within ten (10) days of receipt of oral or written notice of the imposition of any such penalty, whichever is first, if both oral and written notice is provided, file a Notice of Appeal with the City Clerk and have such matter reviewed by the Common Council.

TO AMEND VARIOUS SECTIONS OF 10.076 OF THE CODE OF GENERAL ORDINANCES FOR THE CITY OF KENOSHA ENTITLED "OUTDOOR CAFE OF A "CLASS B", CLASS "B" AND/OR "CLASS C" LICENSED PREMISES IN A PUBLIC RIGHT-OF-WAY

The Common Council of the City of Kenosha, Wisconsin, do ordain as follows:

Section One: Subsection **10.076 A.4.** of the Code of General Ordinances for the City

of Kenosha, Wisconsin, is hereby amended as follows:

4. "Licensed business" shall mean a business which holds a "Class B", Class "B", ~~and/or~~ "Class C" License ~~and/or a business which holds a Brewers permit issued by the Department of Revenue, State of Wisconsin.~~

Section Two: Subsection **10.76 B.** of the Code of General Ordinances for the

City of Kenosha, Wisconsin, is hereby amended as follows:

B. Permission Required. No holder of a Class "B", Class "B", ~~and/or~~ "Class C" License ~~or holder of a Brewers permit issued by the Department of Revenue, State of Wisconsin~~ may operate under said license(s) in any outdoor area located within a public right-of-way without first having obtained the permission of the Common Council in accordance with the terms and conditions of this Ordinance. Any expansion or change in ownership of the business adjacent to the Outdoor Cafe Area shall require a new application, fee, review and approval.

Section Three: Subsection **10.76 J.2.b.** of the Code of General Ordinances for the

City of Kenosha, Wisconsin, is hereby amended as follows:

b. An Outdoor Cafe Area may be located directly adjacent to and abutting the associated ~~tavern~~ ~~licensed business~~, and/or located where it abuts the curb and is at least two (2') feet from the face of the curb. Outdoor Cafe Areas located adjacent to an approved loading zone shall not be required to be located two (2') feet from the face of the curb. In no case shall the Pedestrian Path be reduced to less than a minimum width of four (4') feet, except where a reduction is permitted under Section M.

Section Four: Subsection **10.076 L.** of the Code of General Ordinances for the

City of Kenosha, Wisconsin, is hereby amended as follows:

L. Enforcement. The enforcement of this Ordinance shall be under the jurisdiction of the Department of Community Development and Inspections and Kenosha Police Department, who shall

have the power to inspect Outdoor DiningCafe Areas to determine compliance with this Ordinance. The Department of Community Development and Inspections shall be primarily responsible for enforcement during regular City Hall working hours. The Kenosha Police Department shall be primarily responsible for enforcement of this Ordinance during all other hours. Violations that are enforced by the Police Department shall be communicated to the Department of Community Development and Inspections.

Section Five: This Ordinance shall become effective upon passage and publication.
