The meeting was called to order at 6:34 p.m. by Chair Wilson.

At roll call, the following members were present: Alderpersons Juliana, Wicklund, Bogdala and Ruffolo. Deputy City Attorney Matthew Knight was present. Alderperson Juliana was excused at 8:00 p.m.

Approval of the minutes of the regular and special meetings held on June 29, 2015.

**It was moved by Alderperson Juliana, seconded by Alderperson Wicklund to approve. Motion carried unanimously.**

It was moved by Alderperson Bogdala, seconded by Alderperson Ruffolo to amend E.6, create a new E.4., renumber after that, and include operation dates of Fridays and Saturdays from May 1 through September 30. Motions carried unanimously. It was moved by Alderperson Bogdala, seconded by Alderperson Ruffolo to approve as amended. Motion carried 3-1, with Alderperson Wicklund voting nay.**

**CITIZEN COMMENTS:** Rich Willie spoke about the lack of public in attendance at the public hearing to contribute regarding the proposed Open Container Entertainment District ordinance.

**STAFF/ALDERMEN COMMENTS:** Alderperson Wilson spoke, disagreeing with Mr. Willie's comment and stating that all meeting agendas and backup documents are posted for the public to view.

**Chief Morrissey spoke and expressed that he thought there was a great working relationship between the Licensing & Permit Committee, Tavern League and Police Department and that he had not had to worry about large crowd fights within the past year. He also spoke in support of the proposed Open Container Entertainment District ordinance, stating that it would be a good pilot program.**

**Aldersperson Ruffolo spoke regarding the Outdoor Dining ordinance and reviewed the process of what it took to get the ordinance passed.**

**Aldersperson Bogdala thanked the Licensing and Permit Committee and the co-sponsors of the Open Container Entertainment District ordinance for their ability to work and talk through issues and he appreciates their indulgence.**

**There being no further business to come before the Licensing/Permit Committee, it was moved, seconded and unanimously carried to adjourn at 8:35 p.m.**
