This waiver must include a list of names and addresses of all owners whose property resides within 25 feet of the boundaries of the outdoor extension. This list will be forwarded to the Building Inspector for verification. The City Clerk will notify owners of the dates, times, and locations of the meetings where the outdoor extension application will be discussed. List names and address of owners within 25 feet of the boundaries of the outdoor extension below. In order to notify the above owners, APPLICATIONS ACCOMPANIED BY THIS WAIVER REQUEST MUST BE FILED NO LATER THAN FOURTEEN (14) DAYS BEFORE FINAL ACTION OF THE COMMON COUNCIL\*. 
